




SECTOR BREAKDOWN



CAPITALISATION BREAKDOWN





FUND MANAGEMENT ANALYSIS





- Trump's decisive victory in the US election is expected to provide him with significant leverage to advance his policy agenda.
- In November, the US stock market experienced robust gains, with major indices, including the Nasdaq, reaching new record highs.
- This impressive rally was largely attributed to Trump's victory, as investors anticipated potential benefits from his proposed tax cuts and deregulation policies.
- Conversely, stock markets in China, Europe, and Latin America experienced declines due to concerns over potential tariffs.
- The healthcare sector underperformed, driven by concerns following the nomination of Robert F. Kennedy, who has expressed skepticism about vaccines and aims to cap the prices of expensive drugs.
- Nvidia released its quarterly results in November. While investors were generally satisfied with the results, the company's outlook for the fourth quarter fell short of some analysts' expectations.



PERFORMANCE COMMENTARY

- Over the month of November the fund performed well in absolute terms but lagged its benchmark in relative terms.
- Our overweight to the Consumer Discretionary sector as well as the lack of exposure to Materials was the main contributor to our performance. Amazon, Sony and Marriott were among our best performs over the month
- Nevertheless, our relative performance was mostly affected by our large overweight to Consumer Staples
 and Technology. Although within the Tech sector, Cisco, Service Now and Microsoft were among our largest
 contributors, our Asian Tech positions in Samsung, Lenovo and TSMC were our largest detractors.
- On the Consumer Staples side L'Oreal continued to suffer from its disappointing Q3 numbers. Nestle, similarly suffered from softening in consumer demand as well as their aggressive pricing strategy implemented to offset high input costs as they were slower than competitors to reduce prices as inflation cooled



OUTLOOK AND INVESTMENT STRATEGY

- Over the month of November, we sold out of Edenred as the CHX score was deteriorating.
- We reduced slightly our exposure to Samsung and UBS while adding to our existing position in SAP and Siemens.
- We remain cautious in positioning our portfolio and continue to focus on quality, less cyclical companies.



GLOSSARY

Active Management: An investment management approach where a manager aims to beat the market through research, analysis and their own judgement.

Active share: Portfolio active share measures how different from the reference indicator the portfolio is. The closer the active share is to 100%, the less identical stocks a portfolio has compared to its reference indicator, thus the more active the portfolio manager is compared to the market.

Active Weight: Represents the absolute value of the difference between the weight of a holding in the manager's portfolio and the same holding in the benchmark index.

Alpha: Alpha measures the performance of a portfolio compared to its reference indicator. Negative alpha means the fund performed less well than its reference indicator (e.g. if the indicator increased by 10% in one year and the fund increased by only 6%, its alpha is -4). Positive alpha means the fund performed better than its reference indicator (e.g. if the indicator increased by 6% in one year and the fund increased by 10%, its alpha is 4).

Beta: Beta measures the relationship between the fluctuations of the net asset values of the fund and the fluctuations of the levels of its reference indicator. Beta of less than 1 indicates that the fund "cushions" the fluctuations of its index (beta = 0.6 means that the fund increases by 6% if the index increases by 10% and decreases by 6% if the index falls by 10%). Beta higher than 1 indicates that the fund "magnifies" the fluctuations of its reference indicator (beta = 1.4 means that the fund increases by 14% when the index increases by 10% but also decreases by 14% when the index decreases by 10%). Beta of less than 0 indicates that the fund reacts inversely to the fluctuations of its reference indicator (beta = -0.6 means that the fund falls by 6% when the index increases by 10% and vice

Capitalisation: A company's stock market value at any given moment. It is obtained by multiplying the number of shares of a company by its stock exchange

Investment/net exposure rate: The investment rate constitutes the volume of assets invested expressed as a percentage of the portfolio. Adding the impact of the derivatives to this investment rate results in the net exposure rate, which corresponds to the real percentage of asset exposure to a certain risk. Derivatives can be used to increase the underlying asset's exposure (stimulation) or reduce it (hedging).

Net asset value: Price of all units (in an FCP) or shares (in a SICAV).

SFDR Fund Classification: Sustainable Finance Disclosure Regulation (SFDR) 2019/2088. EU Act that requires asset managers to classify funds into categories, "Article 8" funds promote environmental and social characteristics, "Article 9" funds have sustainable investments as a measurable objective. Sharpe ratio: The Sharpe ratio measures the excess return over the risk-free rate divided by the standard deviation of this return. It thus shows the marginal return per unit of risk. When it is positive, the higher the Sharpe ratio, the more risk-taking is rewarded. A negative Sharpe ratio does not necessarily mean that the portfolio posted a negative performance, but rather that it performed worse than a risk-free investment.

SICAV: Société d'Investissement à Capital Variable (Open-ended investment company with variable capital)

VaR: Value at Risk (VaR) represents an investor's maximum potential loss on the value of a financial asset portfolio, based on a holding period (20 days) and confidence interval (99%). This potential loss is expressed as a percentage of the portfolio's total assets. It is calculated on the basis of a sample of historical data (over a two-year period).

Volatility: Range of price variation of a security, fund, market or index, which enables the measurement of risk over a given period. It is determined using the standard deviation obtained by calculating the square root of the variance. The variance is obtained by calculating the average deviation from the mean, which is then squared. The greater the volatility, the greater the risk.

ESG score Calculation: Only the Equity and Corporate Bond holdings of the fund considered. Sustainable Investments: The SFDR defines sustainable investment as an investment in an economic activity that contributes to an environmental or social objective, provided that the investment does not significantly harm any environmental or social objective and that the investee companies follow good governance practices.

Taxonomy Alignment: In the context of an individual company, taxonomy alignment is defined as the proportion of a company's revenue that comes from activities that meet certain environmental criteria. In the context of an individual fund or portfolio, alignment is defined as the portfolio-weight weighted average taxonomy alignment of included companies.
